#### **Rules Corner**

Playing the Wrong Ball in Stroke Play (Rule 6.3):

You accidentally hit someone else's ball. Now what? You incur a 2 stroke penalty and must complete the hole by playing your own ball. Any and all strokes made using the wrong ball are cancelled.

**Example:** I hit my tee shot into the rough. I see a ball in the rough and play it. I hit it again but when I go to hit that ball again I finally realize it is not my ball. I now have to go back and look for my original ball in the rough. I find it and this time I make sure it's my ball. I am now lying 3. One for the tee shot plus 2 penalty strokes. I hit my ball onto to the green (4) and two putt for a 6. What if I can't find my original ball? Now it is a lost ball. I incur a two stroke penalty for hitting the wrong ball and must proceed under the lost ball options where I will incur an additional stroke and distance penalty or a 2 stroke penalty depending on which lost ball option I select. What does the person do whose ball I hit? They must drop a ball at the approximate location where their ball was and play out from there. They are not penalized.
